UAB researchers make the economic case for Alabama Medicaid expansion

Advocates for extending health coverage to low-income adults have called Medicaid expansion a bargain Alabama can't afford to miss. Critics of the optional expansion under the Affordable Care Act say Alabama can't afford even a small share of long-term costs. (The federal government will pay the full cost from 2014-17, with states picking up a maximum of 10 percent in later years.)

Now, two researchers at the UAB School of Public Health — Dr. David Becker and Dr. Michael Morrisey — have spelled out what Medicaid expansion would mean for our state's economy and tax revenues. At the conference, we'll hear first-hand how Becker and Morrisey designed and carried out their study, "An Economic Evaluation of Medicaid Expansion in Alabama under the Affordable Care Act," and how it can help state policymakers assess this momentous decision.

The timing for Becker and Morrisey's presentation couldn't be better. Coming just a week after the Medicaid Advisory Commission's recommendations to the governor on program reforms and during the opening week of the 2013 legislative session, our keynote panel will give conference-goers fresh insights into a historic opportunity to move Alabama forward.
